**Crafts must be produced by the vendor, must meet market criteria (see the handbook on the website) and will be juried by the board.** Homer Farmers' Market is chartered to promote local agriculture and, as such is not primarily a crafter's market. HFM recognizes the importance of value-added craft products to the local market economy and will attempt to accommodate crafters when possible, while working to maintain an overall focus on agricultural products. The Market Advisory Board will meet to evaluate Craft Vendor applications. New vendors will be asked to show samples of their crafts. Criteria are stated in the HFM Policy Handbook. There are a limited number of full season craft spaces available, not to exceed 30% of market space. Additional Craft Vendors are accepted on a space available basis. **Craft Vendors who wish to be included in the evaluation process for the upcoming season need to submit an application (and fees) by the annual meeting in January.** Craft Vendors who meet this deadline will be notified by March 31st if they are accepted for the season. Applications received after the deadline will be evaluated for inclusion on the space available call-up list.

### **Homer Farmers' Market Mission Statement**

The Homer Farmers' Market welcomes all local growers of farm, garden and greenhouse produce to participate in a weekly market. The Homer Farmers' Market was established in 2000 to aid in the development of a sustainable local agricultural community for the benefit of the greater Kachemak Bay area.

### **Market Operation**

The Homer Farmers' Market is an open-air market located at 1211 Ocean Drive. Hours of operation will be 10 AM to 3 PM every Saturday starting May 29, 2010 to September 25, 2010. Wednesday Markets will begin July 7, 2010 from 3 PM to 6 PM.

### **Craft Criteria**

Priority is given to crafts made with natural, sustainable, and environmentally friendly materials, especially when locally grown or harvested.. ...

- Sale of NON-ALASKAN GROWN produce or NON-ALASKAN MANUFACTURED products will not be permitted. Peddling (resale) is prohibited.
- Each vendor will provide his/her own containers and standard method of measurement used in determining price and use proper labeling.
- Vendors are to provide their own sunshade or rain protection, if necessary.
- A table or bench is acceptable for display of products; limited space is also available on a first come/first serve basis for tailgate sales from pickups and station wagons.
